All other purse monies paid corresponding with purse schedule in Condition Book. WEIGHT: 122 lbs. Maidens allowed 5 lbs. HIGH WEIGHTS PREFERRED. (WINNERS PREFERRED). (Non-starters least preferred). Total earnings will be used in determining the order of preference of horses assigned equal weights. Horses not drawing a starting position in the gate will receive a refund of the entry fee. A trophy will be presented to the winning owner.
