FOR MINNESOTA BRED TWO YEAR OLDS WHICH PASSED THROUGH THE SALES RING OF THE 2016 MINNESOTA THOROUGHBRED ASSOCIATION YEARLING SALE AND WERE PURCHASED BY NEW OWNERS AND CORRESPONDING MINNESOTA BRED CONSIGNOR NOMINATIONS By subscription of \$200 to the MTA by Saturday, April 1. \$200 to enter, \$200 additional to start. \$40,000 Guaranteed (Includes \$25,000 from the Mystic Lake Purse Enhancement Fund and \$10,000 from the Minnesota Thoroughbred Association) of which \$24,000 to the owner of the winner. All other purse monies paid corresponding with purse schedule in the Condition Book. The original owner who consigns a yearling to the 2016 Minnesota Thoroughbred Association Yearling Sale and whose yearling passes through the sales ring shall receive a right to nominate one Minnesota Bred yearling to the race. If the yearling does not sell, the consignor may only nominate the yearling presented at the sale with that consignor nomination. The right may be sold or transferred. (A \$50 fee must be paid to the MTA to record a transfer). Weights: Colts and Geldings - 122 lbs; Fillies - 119 lbs. Maidens allowed 5 lbs. Starters to be named through the entry box by the usual time of closing. The MTA Sales Graduate Futurity will be limited to twelve (12) starters. Sales graduates shall have first preference. High weights on the scale shall have second preference. Total earnings will be used in determining the order of preference of horses assigned equal weights. Failure to draw into the race will result in a refund of the entry fee. A trophy will be presented to the winning owner.
