



MTA STALLION AUCTION STAKES

\$60,000 Guaranteed

(Includes \$30,000 from the Mystic Lake Purse Enhancement Fund)

(Plus \$6,000 from MBF for MN Breds)

FOR THREE YEAR OLDS WHICH ARE 2019 PROGENY OF STALLIONS WHOSE SERVICE WAS SOLD AT THE 2018 MTA STALLION AUCTION \$300 to nominate Friday, by April 1. Late nomination fee: \$750 by Wednesday, June 1. Supplemental nominations of \$3,000 will be accepted at time of entry which shall include all fees. \$300 to enter, \$300 additional to start. All nominations must be made through the MTA. \$60,000 Guaranteed (Includes \$30,000 from Mystic Lake Purse Enhancement Fund) (Includes \$12,500 from the Minnesota Thoroughbred Association)(Plus \$6,000 from the Minnesota Breeders Fund for Minnesota Breds) of which \$36,000 to the owner of the winner. All other purse monies paid corresponding with purse schedule in the Condition Book. Weight: 122 lbs. Maidens allowed 5 lbs. Starters to be named through the entry box by the usual time of closing. The MTA Stallion Auction Stakes will be limited to fourteen (14) starters. High weights on the scale will be preferred (winners preferred). Total earnings will be used in determining the order of preference of horses assigned equal weights. Failure to draw into the race will cancel all fees. A trophy will be presented to the winning owner by the Minnesota Thoroughbred Association. The final purse will be reduced by the cost of any Out of Competition testing required by the Minnesota Racing Commission as a condition of competing in this race.
