FOR QUARTER HORSES, TWO YEARS OLD \$100 to nominate by Tuesday, March 1. \$300 sustaining payment by Friday, April 1. \$400 sustaining payment by Sunday, May 1. \$500 sustaining payment by Wednesday, June 1 and \$700 to enter the trials. Total amount due: \$2,000 (includes all fees). LATE FEE SCHEDULE: \$600 to nominate by Friday, April 1 plus sustaining payments. \$1,500 by Sunday, May 1 plus all sustaining payments. \$2,500 by Wednesday, June 1 plus entry payment and \$5,000 to enter the trials and includes all fees. PAYMENTS MUST BE POSTMARKED BY THE DATE DUE OR LATE FEES WILL APPLY. \$175,000 Estimated (Includes \$24,000 from the Mystic Lake Purse Enhancement Fund) Purse to be distributed to the 10 fastest qualifiers, of which 42% to the owner of the winner, 17% to second, 10% to third, 7% to fourth, 6% to fifth, 5% to sixth, 4% to seventh and 3% each to eighth, ninth and tenth. Weight: 124 lbs. Management reserves the right to run 11 horses in the Mystic Lake Northlands Futurity final, with no trials, if 11 horses or fewer enter into the trials, paying purse monies only to the top 10 finishers. Management reserves the right to cancel, change or postpone the trials and/or final. A trophy will be presented to the winning owner. The final purse will be reduced by the cost of any Out of Competition testing required by the Minnesota Racing Commission as a condition of competing in this race. Trials to be run Wednesday, July 27.
