**(Plus \$7,500 from MBF for MN Breds)**

**FOR FILLIES, THREE YEARS OLD** Free nomination by Wednesday, June 7. \$375 to enter, \$375 additional to start. Supplemental nominations of \$1,500 will be accepted at time of entry which shall include all fees. \$75,000 Guaranteed (Plus \$7,500 from the Minnesota Breeders Fund for Minnesota Breds) of which \$45,000 to the owner of the winner. All other purse monies paid corresponding with purse schedule in the Condition Book. Weight: 122 lbs. Non-winners of a sweepstakes at a mile or over in 2023 allowed 2 lbs.; \$30,000 at a mile or over in 2023 allowed 4 lbs.; \$18,000 at a mile or over in 2023 allowed 6 lbs. Maidens allowed 8 lbs. (Maiden and claiming races not considered in allowances). Starters to be named through the entry box by the usual time of closing. The maximum field size for the Curtis Sampson Oaks will be determined by rail setting. High weights on the scale will be preferred, followed by Graded Stakes winners 12 months prior to race date, Graded Stakes placed 12 months prior to race date, Stakes winners within 12 months, Stakes placed within 12 months, then highest earnings in non-claiming/starter races in the past 12 months prior to race date. Canterbury Park reserves the right to refuse any nomination or entry into this race. Failure to draw into the race (including MTO entries in the event the race remains on the turf) will cancel all fees. A trophy will be presented to the winning owner. The final purse will be reduced by the cost of any Out of Competition testing required by the Minnesota Racing Commission as a condition of competing in this race.
