The final purse shall be reduced by the cost of any Out of Competition testing required by the Minnesota Racing Commission as a condition of competing in this race. The \$15,000 Guaranteed Northlands Juvenile will be offered to horses that entered the trials but failed to qualify for the final. Must have a minimum of 24 entrants into the Northlands Futurity trials for the Northlands Juvenile to be contested.
