FOR QUARTER HORSES, TWO YEARS OLD, WHICH ARE 2023 PROGENY OF STALLIONS WHOSE SERVICE WAS SOLD AT THE 2022 MQHRA STALLION AUCTION \$300 to nominate by Tuesday, April 1. \$600 sustaining payment by Thursday, May 1 and \$600 to enter the trials. Total amount due: \$1,500 (includes all fees). Late payments double fees. PAYMENTS MUST BE POSTMARKED BY THE DATE DUE OR LATE FEES WILL APPLY. (All nominations and sustaining payments must be made through the MQHRA.) \$82,500 Estimated (Estimated \$67,500 from the MQHRA which includes all nomination and sustaining payments) (Plus \$5,000 from the Minnesota Breeders' Fund for horses Sired & Foaled in Minnesota) Purse to be paid in accordance with MQHRA Stallion Auction Futurity Rules. Weight: 124 lbs. Starters to be named through the entry box by the usual time of closing. Management reserves the right to run 10 horses in the MQHRA Stallion Auction Futurity final, with no trials, if 10 horses or fewer enter into the trials. Management reserves the right to refuse any nomination or entry into this race or to cancel, change or postpone the trials and/or final. The MQHRA Stallion Auction Consolation will be contested in the event 40 or more horses enter into the MQHRA Stallion Auction Futurity trials. In the event a Consolation is contested, the purse money will be distributed from the final purse of the MQHRA Stallion Auction Futurity. A trophy will be presented to the winning owner. The final purse will be reduced by the cost of any Out of Competition testing required by the Minnesota Racing Commission as a condition of competing in this race. (TRIALS TO BE RUN WEDNESDAY, JUNE 25).
