FOR COLTS AND GELDINGS, TWO YEARS OLD WHICH ARE REGISTERED MINNESOTA BREDS. \$75,000 Guaranteed (Includes \$5,000 from the Minnesota Breeders' Fund). Six Furlongs. Weight: 122 lbs. Maidens allowed 5 lbs. Starters to be named through the entry box by the usual time of closing. The Northern Lights Futurity will be limited to fourteen (14) starters. High weights on the scale will be preferred (Winners preferred). Total earnings will be used in determining the order of preference of horses assigned equal weights. Failure to draw into the race will result in a refund of the entry fee. A trophy will be presented to the winning owner.
