Management reserves the right to cancel, change or postpone the trials and/or final. Late payments double fees. A trophy will be presented to the winning owner. The final purse shall be reduced by the cost of any Out of Competition testing required by the Minnesota Racing Commission as a condition of competing in this race. *There will be no consolation race offered for the Northlands Futurity.*
