FOR FILLIES, THREE YEARS OLD WHICH ARE REGISTERED MINNESOTA BRED \$250 to nominate by Wednesday, April 1. Late nomination fee: \$750 by Monday, June 1. \$500 to enter, \$500 additional to start. Supplemental nominations of \$3,000 will be accepted at time of entry which shall include all fees. \$75,000 Guaranteed (Includes \$5,000 from the Minnesota Breeders' Fund) of which \$45,000 to the owner of the winner. All other purse monies paid corresponding with purse schedule in the Condition Book. Weight: 122 lbs. Maidens allowed 5 lbs. Starters to be named through the entry box by the usual time of closing. The Minnesota Oaks will be limited to fourteen (14) starters. High weights on the scale will be preferred (winners preferred). Total earnings will be used in determining the order of preference of horses assigned equal weights. Canterbury Park reserves the right to refuse any nomination or entry into this race. Failure to draw into the race will result in a refund of the entry fee. A trophy will be presented to the winning owner. The final purse will be reduced by the cost of any Out of Competition testing required by the Minnesota Racing Commission as a condition of competing in this race.
