FOR FILLIES AND MARES, THREE YEARS OLD AND UPWARD WHICH ARE REGISTERED MINNESOTA BRED Free nomination by Saturday, August 22. \$250 to enter, \$250 additional to start. Supplemental nominations of \$1,000 will be accepted at time of entry which shall include all fees. \$55,000 Guaranteed (Includes \$10,000 from the Minnesota Breeders' Fund) of which \$30,000 to the owner of the winner. All other purse monies paid corresponding with purse schedule in the Condition Book. Weights: Three year olds - 120 lbs.; Older - 124 lbs. Non-winners of a sweepstakes in 2026 allowed 2 lbs., \$21,000 in 2026 allowed 4 lbs., \$17,400 in 2026 allowed 6 lbs. (Maiden, claiming and starter races not considered in allowances.) Starters to be named through the entry box by the usual time of closing. The Bella Notte Minnesota Distaff Sprint Championship will be limited to fourteen (14) starters. High weights on the scale will be preferred. Total earnings in 2025-2026 will be used in determining the order of preference of horses assigned equal weights. Canterbury Park reserves the right to refuse any nomination or entry into this race. Failure to draw into the race will cancel all fees. A trophy will be presented to the winning owner. The final purse will be reduced by the cost of any Out of Competition testing required by the Minnesota Racing Commission as a condition of competing in this race.
