

Beginning August 27, 2026, \$10 Super Satellite contests will be held each week through December 12 that will qualify players for an entry fee to the One Shot NHC Qualifier Contest on December 19 which will award entry, \$500 for travel expense, and accommodations to the National Horseplayers Championship in 2027.

Players will be allowed to play in three \$10 Super Satellite contests EACH series choosing from Thursday, Friday, and/or Saturday. In each series each week the highest individual score from each three-day contest period determines the winner of that series. Three selected tracks (eight races at each track) are offered each day of the series. Players can enter three contests in one day (no more than one entry per track per day) if they so choose but total entries for a contest series cannot exceed three. Each entry is \$10 per contest track with a limit of three per series.

Each week, one winner for every 10 entries will receive an entry to One Shot NHC Qualifier Contest on December 19. The entry is valued at \$100. **Winners must provide \$50 NHC Tour ID to play on December 19. NHC ID is not included in prize.**

The Super Satellite contest format requires entrants to select one horse in each of the eight contest races and submit the selections before entry deadline. Points will be awarded for selections based on the official mutuel payoffs based on a mythical \$20 across-the-board wager. Entrants must be 21 years of age or older. The maximum point payoffs per race for win, place, and show will be capped in the following manner. The maximum points possible for win will be 600 points, for place 400 points; and for show 200 points. The contest winner will be the player accumulating the most points in an individual contest over the three-day contest period.

One winner for every 10 entries will receive an entry to One Shot NHC Qualifier Contest on December 19. The entry is valued at \$100. Winners must provide \$50 NHC Tour ID to play on December 19. NHC ID is not included in prize. Extra entry fees from each period will be divided with 60% being paid to the player with the highest score that did not win a Dec. 19 entry each period; 40% will be aggregated over the entire contest span and will be paid as a bonus to the player that scores the highest individual contest score over the entire contest span.
